NEW EVIDENCE IN BURNS CASE.

District Attorney Said to Have Discov-
ered an Important Witness.

Several persons were examined at the case of Florence Burns, accused of the murder of Walter Brooks, accused of the murder from Brooklyn, a neighbor of the woman girl, gave testimony which would not be revealed at the office, and, after her, several other possible witnesses were subjected to long examinations.

It was stated authoritatively in the office of the District Attorney, however, that the four persons who registered at the office Island Hotel on the evening on which Brooks died have been discovered. Their names were not given out, but it was said that they registered as John F. Johnson and wife, and Mr. and Mrs. Bean of New York. One of the women is said to live in Jersey City. It was not denied in the office of the District Attorney that the most important witness in the case is being held back until the proper time for producing evidence against the accused girl.
