



Neale, being duly affirmed, deposes and says that she is a trustee of the association, the applicant named in the foregoing statement, and in such capacity is an officer of said association authorized to transact business in the name of said association; that she believes that the foregoing statement is true; that she believes said association to be the owner of the trade mark sought to be registered; that no other person, firm, corporation or association, to the best of her knowledge and belief, has the right to use said trade mark in the United States of America, either in the identical form shown, or in any such near resemblance thereto as might be calculated to deceive, in connection with the class of goods set forth in the foregoing statement; that said trade mark is used by said association in commerce among the several States of the United States, and between the United States and foreign nations; that the description and drawing presented truly represent the mark sought to be registered; that the specimens show the trade mark as actually used upon the goods, and that the mark was in actual use as a trade mark of the applicant for ten years next preceding the passage of the Act of Feb. 20, 1905, and that to the best of her knowledge and belief such use has been exclusive.
