In answer to your letter of the 20th, we beg to advise that our final account as administrator of the estate of K. Isabelle Sandford has been confirmed by the Court, the Auditor has held his hearing, ordered distribution and distribution has been made to those legally entitled to the same.

The last paragraph of the Auditor's report is as follows: "The income from the balance of said sum remaining is to be paid to J. Adelaide Wilson during her life time and at her decease said balance is to be paid to Della K. Murphy, Norma Clum Cromwell and Wm. Sandford or their personal representative, share and share alike." If you will examine your copy of the will you will find this is in strict accordance with its terms.

My dear Adelaide:

I am doing everything possible to get Aunt Belle's estate cleaned up and here is a copy of letter received from the Trust Company, December 18th, from which you will note that there is a balance from the will of \$451.09, which will be invested by the Trust Company and the interest sent you twice a year.

At the present time, I do not know whether they have it invested at 2% or 4%, but after we get the real estate cleaned up, we will take that matter up and insist that they put it at a reasonably good interest.

As to the money from the sale of the Urbana property, I am corresponding with the Trust Company for the purpose of trying to get a distribution of it, however, as you will note from the letter attached, there is only \$581.25 to be divided.

I figure Della and Willie Sandford will each get a third and the other third, amounting to \$193.75 should be divided between you, Florence and Norma. If my interpretation is right, you each should receive \$64.55. Then there will be another division when the Lawrenceville property is sold, which I do not believe will net more than this amount.

I will keep you advise of any further information I receive on the matter.
